## Letter From the Editor

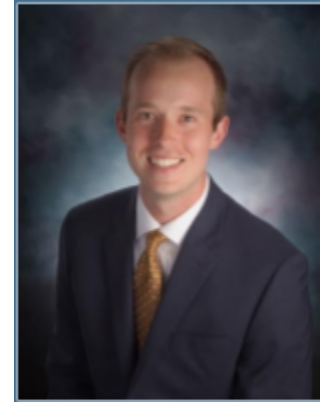
Thank you for picking up the Register!

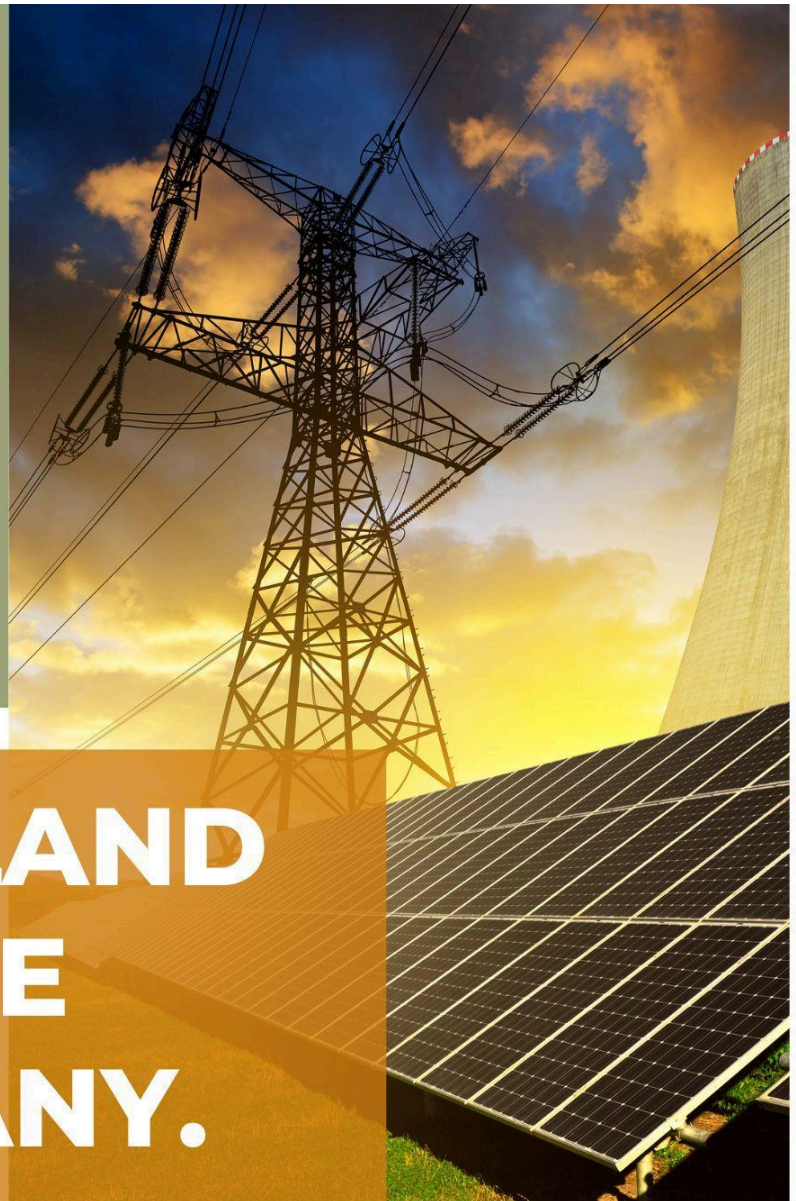

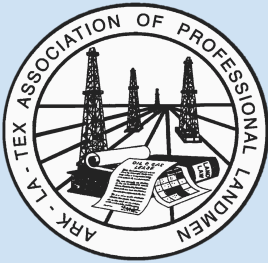

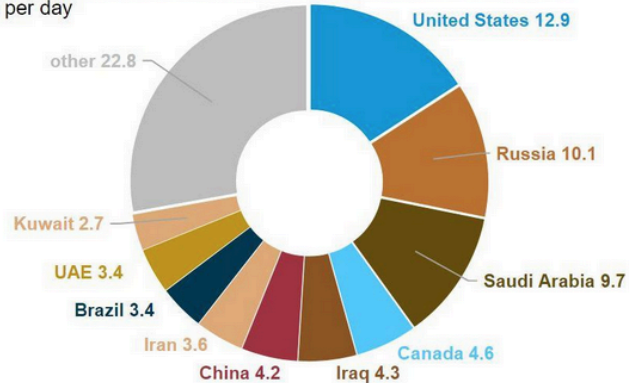

ALTAPL members,

The good old U. S. of A. has been the top oil producing country for 6 years in a row, according to a recent [report](#) by the Energy Information Agency (commonly referred to as the EIA). In fact, over the last 6 years, the US has produced more crude oil (including [condensate](#)) than any country ever has before. Crude oil production averaged 12.9 million barrels per day in 2023, shattering the record of 12.3 million barrels per day, set in 2019. The EIA expects this great nation of ours to remain the world's top producer for the foreseeable future. Here's a chart (your tax dollars at work) showing the top producing countries last year:

## Ken's Corner *(continued)*

Jerry Jones has agreed to invest another 100 million dollars in Comstock Resources. Two of Mr. Jones's business entities will acquire 12.5 million shares of stock in the pure-play Haynesville producer. Jones is already the majority shareholder in Comstock and will soon have a two-thirds interest in the company.

Tellurian's incomplete Driftwood LNG export facility is in jeopardy. The project, some 7 years in the making and still not up and running, is burdened by high interest debt and has been devalued by the recent crash in gas prices.

A few months ago the company's accountants indicated that trouble might be on the horizon. In its annual report Tellurian said the current price environment "may result in write-downs of our natural gas or oil properties." The company indicated that it might sell off some of its producing assets to make up for cash flow shortfalls, but the timing appears to be very bad for that, as gas prices, adjusted for inflation, hit 30 year lows in February.

The Chesapeake-Southwestern merger has drawn the attention of Federal Antitrust regulators. The [HSR filing](#) (required by the Federal Trade Commission under the Hart-Scott-Rodino Act of 1976) has been pulled and refiled to give the feds time to review the proposed transaction, presumably to make sure the surviving entity does not become "too big".

New Mexico is back in the news again this month, as the State Land Office there recently announced that it will withhold lease sales indefinitely for its Permian Basin lands. Several bills have failed to pass the New Mexico state legislature that would raise the maximum royalty rate the state can negotiate from 1/5 to 1/4. Royalty payments received by New Mexico are earmarked for a trust that benefits public schools, colleges and hospitals.

"I am a fiduciary on behalf of the school kids," State Land Commissioner Stephanie Garcia Richard said. "It's my job to make them the most money possible, and leasing these tracts below market rate means that school kids are subsidizing the oil and gas activity."

Natural gas spot prices have risen slightly to about \$1.65 per MMBtu at the time of this writing in late March, up about 5 cents from last month's report. The 52 week extremes for natural gas prices were \$1.58 and \$3.52. On that same day in late March, West Texas Intermediate Crude Oil closed at \$ 80.88, up about \$2.44 from last month's report. Natural gas futures strips for the next 12 months range from \$1.83 for May delivery, up to \$3.72 for January 2025 then down to \$2.68 for April 2025. That same range for crude oil futures shows a gradual slide to \$74.53 in April 2025.

## Ken's Corner *(continued)*

The rig count in our area is down by roughly 17 percent since our last report, which is no surprise given the current price environment. As of the fourth Friday in March, and according to Baker-Hughes, 44 drilling rigs were running in the Ark-La-Tex area (down 9 from last report). There were 26 rigs running in North Louisiana (down 5 from our last report). In East Texas 16 rigs were running in Railroad Commission Zone 6 (the easternmost zone, down 3 from our last report), and 2 rigs were running in Zone 5 (the westernmost zone of East Texas, down 1 from last month). As has been the case for years now, no rigs were reported running in Arkansas or Mississippi. The total (onshore and offshore) U.S. rig count was 624, down 2 from last report. Eighteen offshore rigs were working in Louisiana's coastal waters, up 4 from our last report, and 3 rigs were running in the coastal waters of Texas, down 1 from our March report.

That's all for this month, I hope to see you all at the April membership meeting at the Petroleum Club on Monday, April 8. Brooks Yates CPL, current AAPL president, will speak after lunch.

## AAPL Director's Report

I recently attended the AAPL Board of Directors quarterly meeting, which was held March 9-10, 2024, in Tulsa, Oklahoma.

Every year at the March meeting, the Board of Directors is informed about the award winners for the year, with the awards to be presented at the annual meeting, to be held this year in Boston, Massachusetts. I am proud to let you know that the ALTAPL *Register* won the award for Newsletter of the Year! Congratulations to David Smith, the editor last year, and all of those who helped get the winning edition submitted. There are 38 local associations, so this is a huge honor, and we are fortunate to have great local talent make sure our monthly newsletter provides timely information regarding ALTAPL activities, current trends, recent updates to cases and laws, as well as well permit information for our area. Drew Burnham is doing a great job this year putting out quality editions of *The Register* month after month. This is no easy task, so take a moment to let him know you appreciate his efforts.

At each board meeting in March, the AAPL annual budget is reviewed and approved. I am happy to report that the 2024-25 budget is projected to have a small surplus, welcome news after several years of negative balances for the budget. Also, the Policy and Bylaws task force has completed a two-year process of reviewing, updating, and proposing changes to AAPL policies and bylaws. Most of the changes are benign and have little real impact on members, but rather eliminate conflicts and address the need to update these documents to conform to current committee activities and recent changes in our industry. Eligible AAPL members will have the opportunity to vote on the proposed bylaws changes, and that vote should take place in the late spring. Before the vote occurs there will be a 60-day window for review and comment regarding any proposed changes to the bylaws. The vote should take place before the 2024 AAPL annual meeting, and the results will be announced before the annual business meeting in Boston on June 20, 2024.

This year the annual meeting will be held in Boston, Massachusetts, June 19-21, 2024. Boston is a great venue, and I hope many ALTAPL members will attend. Remember, AAPL offers members Education Assistance of up to \$300.00 for events such as the Annual Meeting. You can apply online at [landman.org](http://landman.org), and under the Professional Development banner, click on Education Assistance. To be eligible, membership in AAPL for two consecutive years is required. This education assistance is available twice per calendar year for eligible members. The annual meeting will offer great educational opportunities, networking opportunities, social events, and the chance to visit one of the great cities in the US. If you have questions, please reach out, I am always happy to share any information I can.

The Board of Directors for AAPL has nominated a slate of officers for the 2024-25 year. All voting is done electronically, so if you have not received your ballot by email, let me know. I will make sure you receive a ballot. I am fortunate that I know all of the candidates, and we will be well served by this Executive Committee. ## **Louisiana Legislative Update**

### **W. Drew Burnham, Cook, Yancey, King & Galloway APLC**

The Louisiana legislative session began on March 11, 2024, and there are several proposed bills which may affect the practice of landmen, particularly in the negotiation, drafting, and analysis of servitudes.

SB 108 is a bill authored by one of our local senators, Alan Seabaugh, and it proposes a modification to the present law concerning the right of expropriation for certain non-governmental entities. As you are likely aware, certain non-governmental entities, like utility and pipeline companies, may have the right to expropriate private property for public use, upon the payment of just compensation to the landowner. While many companies with this power still negotiate servitudes from landowners, the threat of expropriation is always a threat hanging over the heads of landowners in these scenarios.

The legislation proposed by Senator Seabaugh would limit the non-governmental entities which have the right of expropriation. Specifically, the proposed legislation would eliminate the right of expropriation for entities engaged in the generating, transmitting, or distribution of electricity or steam if the expropriating project is not intended primarily for end users located in Louisiana. With a proposed effective date of August 1, 2024, this proposed legislation has the potential to impact at least one significant transmission project across the north of Louisiana. As of Monday, March 25, 2024, the bill has passed the Senate and has been received by the House.

The next two bills are related to the current series of disputes Energy Transfer, LP, and its subsidiaries, has with several other companies who propose to cross Energy Transfer pipelines with their own projects. As the negotiation of pipeline servitudes and the title work necessary for those lines is big business for landmen in our association, these bills, have the potential to influence the strategic lay of the land moving forward. Both bills are House bills and were passed unanimously by it on Thursday, March 21, then ordered to the Senate.

HB 686 is a bill authored by Representative Jack McFarland which attempts to clarify existing law concerning the extent of servitudes in Louisiana. La. R.S. 9:2726 presently requires that a plat, sketch, or aerial photograph of the servitude be attached to any servitude document. Typically, those depictions of the servitude show the width and the length of the servitude across the surface, but not the depth. Much of the litigation presently pending between pipeline companies concerns what the rights of the pre-existing pipeline company are with respect to the depth below its pipe. The proposed legislation would provide that servitudes without a defined depth shall be limited to the physical space in which the pipeline rests and surrounding space necessary to undertake the servitude's described purpose. The bill states that it is intended to clarify existing law, not change it, and, as amended on Thursday, March 21, would not affect existing servitudes.

HB 612, also authored by Representative McFarland, proposes a modification to the Code of Civil Procedure to create a voluntary process through which a pipeline owner could provide a notice of intent to cross an existing pipeline to the company proposed to be crossed, and to initiate a summary proceeding (i.e. litigation on a fast track) to resolve any subsequent disputes as to the crossing. The required pre-suit notice must detail the specifications for the crossing so that the crossed entity can determine whether it has concerns with safety, with its legal rights, or interference with its use of its own servitude. After thirty days have elapsed from the receipt of that notice, the crossing party may institute the summary proceeding. The legislation proposed would provide a fast-track procedure even to the litigation already pending in the courts up and down the western side of Louisiana. As litigation through ordinary process can often take years to complete, this bill constitutes a welcome procedure for companies wishing to construct new pipelines and not be potentially held hostage by existing pipelines the new project must cross.

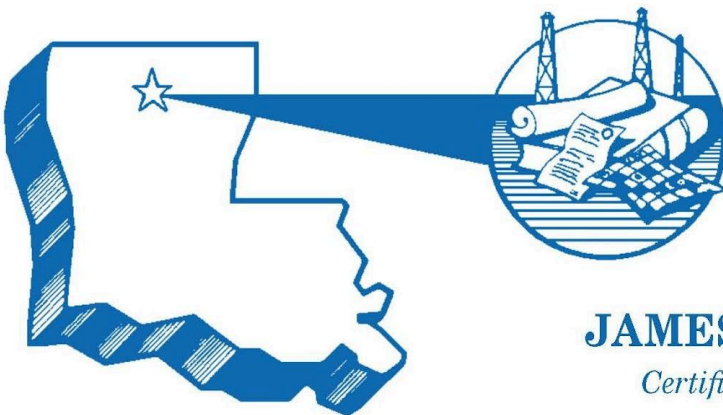

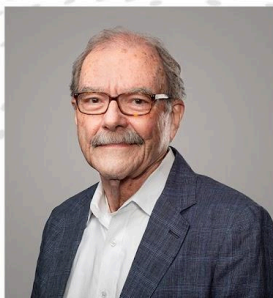

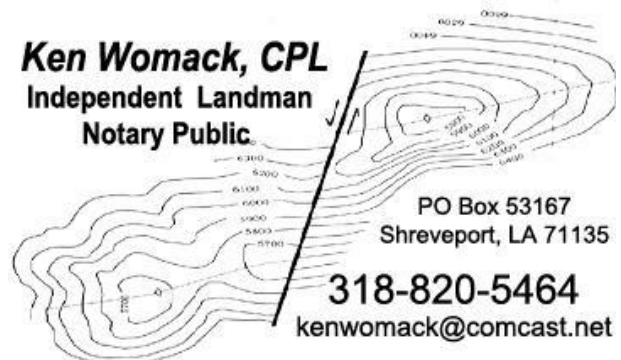
